## JVC Announces Revision of Non-Consolidated Business Forecast and Cash Dividend Forecast for Fiscal 2006

Victor Company of Japan, Limited (JVC) revised its earlier non-consolidated business forecast for fiscal 2006 (April 1, 2005 through March 31, 2006) as in the tables below. Previous forecast was announced on February 21, 2006.

### Reasons for revision of non-consolidated business forecast

The previous forecast for the ordinary income and current net income will be revised, because, for the ordinary income, there was a worsening of non-operating income due to such factors as reduction in dividends from affiliated companies and, for the current net income, there was a drop in the revised forecasted figure due to an increase in valuation allowance for investment in securities accompanying the termination of production activities for a Germany manufacturing company.
